In the following, we would like to inform you about the processing of personal data in connection with the use of the log-in area on the website FST.com of Freudenberg FST GmbH. Freudenberg FST GmbH is responsible for the technical provision of the log-in area and provides downloads about its products and materials.

## **Purpose of data processing**

## **Processing:**

When using " Log-In FST.com ", various types of data are processed.

User details when registering: first name, last name, e-mail, company.

If you have accepted the setting of cookies when accessing the website, the following information is also stored in your profile:

Usage metadata: e.g. date and time of last visit, last interaction, location,

Content interaction data: e.g. path of files downloaded, number of files downloaded, web pages visited on FST.com, forms completed.

## **Legal basis**

The registration process is based on Art. 6(1)(a) EU GDPR, your active consent to data processing.

In the event of the establishment of a contractual relationship with you as a representative of a company and thus as a customer of FST, the relevant legal basis is Art. 6 (1) lit. f) GDPR. The legitimate interest for this data processing then lies in the context of the fulfilment of the contract with you as a business customer of FST.

### **Recipients / transfer of data**

Personal data processed in connection with the use of the " Log-In FST.com " are stored in our CMS (content management system). These are enriched with usage metadata and content interaction data for evaluation purposes in order to constantly improve the customer-friendliness of our website. However, this only takes place if you have consented to the setting of cookies when accessing the website.

We delete all personal data in our CMS as soon as it is no longer required for the purpose for which it was collected or you have exercised your right to have it deleted. If there are legal retention obligations or one of the other exceptions from Art. 17 GDPR applies, we will delete the data concerned as soon as possible.

### **Data processing outside the European Union**

As a rule, data processing outside the European Union (EU) does not take place, as we have limited our data storage location to data centres in the European Union. However, we cannot rule out the possibility that data may be routed via Internet servers located outside the EU, especially for users outside Europe. However, the data is encrypted during transport via the internet and is therefore protected from access by third parties.

### **Your rights as a data subject**

You have the right to be informed about the personal data concerning you.

In the event of a request for information that is not made in writing, please understand that we may ask you to provide evidence that you are the person you claim to be.

you claim to be. In addition, you have the right to rectification or erasure or to restriction of processing to the extent that you are entitled to do so by law.

Finally, you have the right to object to processing in accordance with the law.

### **Right to complain to a supervisory authority**
